STIPULATION

a Justice of the Plymouth Town Court,
Chenango County.

IT IS HEREBY STIPULATED AND AGREED by and between Robert H. Tembeckjian, Administrator and Counsel to the Commission on Judicial Conduct, and the Honorable Gladys C. Branagan (“Respondent”), as follows:

1. Respondent initially served as a Justice of the Plymouth Town Court, Chenango County, from January 1, 2000, to December 31, 2007. After being out of office for over a decade, Respondent was elected to a new term as a Justice of the Plymouth Town Court, which began on January 1, 2019, and expires on December 31, 2022. Respondent is not an attorney.

2. Respondent was served with a Formal Written Complaint dated May 14, 2020, containing five charges related to her prior service as Plymouth Town Court Justice.¹ The charges included the improper or untimely execution of various judicial duties, such as reporting and accounting for court cases and funds, and her failure to

¹ The Commission was investigating the matters herein when its jurisdiction ended upon the expiration of Respondent’s previous term of office as Plymouth Town Court Justice on December 31, 2007. Her return to office revived the Commission’s jurisdiction. See *Matter of Bailey*, 67 NY2d 61 (1986).

cooperate with investigations or inquiries into such matters by appropriate government agencies. A copy of the Formal Written complaint is appended as Exhibit 1.

3. Respondent enters into this Stipulation in lieu of filing an Answer to the Formal Written Complaint.

4. Respondent has tendered her resignation, dated July 13, 2020, and effective August 31, 2020. A copy is appended as Exhibit 2.

5. Pursuant to Section 47 of the Judiciary Law, the Commission has 120 days from a judge's resignation to complete proceedings and, if it so determines, render and file a determination that the judge should be removed from office.


6. Respondent affirms that, upon vacating her judicial office on August 31, 2020, she will neither seek nor accept judicial office at any time in the future.

7. Respondent understands that, should she abrogate the terms of this Stipulation and hold any judicial position at any time after August 31, 2020, the present proceedings before the Commission will be revived and the matter will proceed to a hearing before a referee.

8. Upon execution of this Stipulation by the signatories below, this Stipulation will be presented to the Commission with the joint recommendation that the matter be concluded, by the terms of this Stipulation, without further proceedings.

9. Respondent waives confidentiality as provided by Section 45 of the Judiciary Law, to the extent that (A) this Stipulation will become public upon being signed by the signatories below, and (B) the Commission's Decision and Order regarding this Stipulation will become public.

**FORMAL
WRITTEN COMPLAINT**

1. Article 6, Section 22, of the Constitution of the State of New York establishes a Commission on Judicial Conduct (“Commission”), and Section 44, subdivision 4, of the Judiciary Law empowers the Commission to direct that a Formal Written Complaint be drawn and served upon a judge.

2. The Commission has directed that a Formal Written Complaint be drawn and served upon Gladys C. Branagan (“Respondent”), a Justice of the Plymouth Town Court, Chenango County.

3. The factual allegations set forth in Charges I through V state acts of judicial misconduct by Respondent in violation of the Rules of the Chief Administrator of the Courts Governing Judicial Conduct (“Rules”).

4. Respondent initially served as a Justice of the Plymouth Town Court, Chenango County, from January 1, 2000, to December 31, 2007. After being out of office for over a decade, Respondent was elected to a new term as a Justice of the Plymouth Town Court which began on January 1, 2019, and expires on December 31, 2022. Respondent is not an attorney.

CHARGE I

5. From on or about August 10, 2001, to in or about November 2008, Respondent failed to report or remit at least \$14,560 in court funds to the Office of the State Comptroller (“State Comptroller”) within ten days of the month succeeding their collection, as required by Section 27(1) of the Town Law, Section 99-a of the State Finance Law, Section 1803 of the Vehicle and Traffic Law, and Sections 2020 and 2021 of the Uniform Justice Court Act. In addition, Respondent failed to act promptly to correct an erroneous check she had written to the State Comptroller for \$14,560 in court funds.

Specifications to Charge I

6. Respondent’s monthly report to the State Comptroller for the calendar month of December 2007, dated January 21, 2008, reported the disposition of 71 cases and the receipt of \$14,560 in court funds. A copy of the report is annexed as Exhibit A.

7. In the December 2007 report, Respondent identified the source of the court funds as follows:

- A. The disposition of 58 cases from which the court had received \$7,930 between in or about July 2001 to in or about June 2007;
- B. The disposition of nine cases from which the court had received \$3,780 in December 2007; and
- C. The disposition of four cases from which the court had received \$2,850, but which had no dates of disposition or receipt of funds.

8. In or about May 2008, Respondent sent a check to the State Comptroller in the amount of \$14,560, the total amount of the court funds identified on the December 2007 report. By letter dated June 5, 2008, the State Comptroller returned the check because Respondent had made an error in writing the check and requested that she send a correctly written check. A copy of the letter is annexed as Exhibit B.

9. Notwithstanding repeated attempts by the State Comptroller in or about July and August 2008 to contact Respondent about remitting proper payment, Respondent failed to properly remit the \$14,560 in court funds to the State Comptroller until in or about November 2008, approximately 11 months after the expiration of her judicial term and well beyond the time for submission of the funds as required by law. A record of Respondent's payment is annexed as Exhibit C.

10. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that she failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that she failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently

discharge her administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

CHARGE II

11. Between in or about February 2004 and in or about August 2007, as set forth on the annexed Schedule 1, Respondent repeatedly failed to file her monthly reports with and remit court funds to the State Comptroller within ten days of the month succeeding their collection, as required by Section 27(1) of the Town Law, Section 99-a of the State Finance Law, Section 1803 of the Vehicle and Traffic Law, and Sections 2020 and 2021 of the Uniform Justice Court Act. During this time period, Respondent was late by as many as 121 days in reporting and remitting court funds. Respondent's failure to timely file her reports and remittances for the months of April 2006, May 2006 and June 2006, resulted in the State Comptroller's office directing that Respondent's judicial salary be stopped on or about August 30, 2006. Respondent failed to file these reports or remittances until September 2006, and she thereafter continued to file tardy reports and remittances.

Specifications to Charge II

12. From in or about February 2004 to in or about August 2007, as set forth on Schedule 1, Respondent failed to timely file 42 out of 43 monthly reports and to timely remit the funds identified in those reports with the State Comptroller.

13. By letter dated August 30, 2006, the State Comptroller directed the Plymouth Town Supervisor to cease payment of Respondent's judicial salary due to Respondent's failure to timely file her monthly reports and remittances with the State

Comptroller for the months of April 2006, May 2006 and June 2006. A copy of the State Comptroller's "stop-salary notice" is annexed as Exhibit D.

14. Respondent failed to file her reports for the months of April 2006, May 2006 and June 2006 with the State Comptroller until in or about September 2006, well beyond the time for submission required by law. With the exception of her report and remittance for the month of October 2006, Respondent continued to be untimely in reporting and remitting to the State Comptroller through August 2007.

15. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that she failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that she failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge her administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

CHARGE III

16. From on or about January 1, 2000, to on or about December 31, 2007, Respondent failed to report any dispositions of traffic tickets to the Department of Motor Vehicles as required by Section 514(1) of the Vehicle and Traffic Law and Sections 91.12 and 91.19 of the Regulations of the Commissioner of Motor Vehicles, notwithstanding that there were hundreds of traffic cases handled by the court in that time.

17. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that she failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that she failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge her administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

CHARGE IV

18. From in or about April 2007 through on or about December 31, 2007, Respondent failed to cooperate with the Commission's investigation of two complaints alleging that she (A) failed in two criminal cases to timely return bail moneys posted on behalf of defendants, notwithstanding numerous requests following her disposition of the cases, and (B) failed to file reports or remit funds to the State Comptroller in the time required by law for the months of April 2006 through June 2006, resulting in her judicial salary being stopped on August 30, 2006.

Specifications to Charge IV

19. By letter dated April 9, 2007, the Commission notified Respondent that it was investigating a complaint alleging that in two criminal cases she failed to timely return bail moneys posted on behalf of defendants, notwithstanding numerous requests following the disposition of the cases. The letter requested that Respondent respond to the allegations in writing by April 25, 2007. A copy of the letter is annexed as Exhibit E.

20. By letter dated April 25, 2007, Respondent wrote to the Commission that she had been unable to "devote the time required to answer all the questions" in the Commission's letter dated April 9, 2007, but that she was "able to devote the proper time now." A copy of the letter is annexed as Exhibit F.

21. By letter dated April 27, 2007, the Commission notified Respondent that her time to submit a response to the Commission's inquiries was extended to May 9, 2007. A copy of the letter is annexed as Exhibit G. Respondent failed to respond to the letter.

22. By letter dated May 16, 2007, the Commission sent Respondent copies of its letters of April 9, 2007 and April 27, 2007, and requested her response to the April 9, 2007, letter by May 23, 2007. The letter informed Respondent that her “failure to respond may be found by the Commission to be a failure to cooperate with the investigation” (emphasis in original). A copy of the May 16, 2007, letter is annexed as Exhibit H. Respondent failed to respond to the Commission’s letters dated April 9, 2007, April 27, 2007, or May 16, 2007.

23. By letter dated September 12, 2007, the Commission notified Respondent that it was investigating two complaints against her, including the complaint she was previously notified about and a second complaint alleging that she failed to file reports or remit funds to the State Comptroller in the time required by law for the months of April 2006 through June 2006, resulting in her judicial salary being stopped on August 30, 2006.

24. In its September 12th letter, the Commission also requested that Respondent appear to give testimony concerning the complaints at the Commission’s Albany office on September 28, 2007, and notified her that she would be asked about her failure to respond to the Commission’s letters in addition to being asked about the allegations in the complaints. A copy of the September 12, 2007, letter is annexed as Exhibit I.

25. On or about September 27, 2007, Respondent called the Commission and requested an adjournment of her appearance to give testimony. The Commission granted her request. During the telephone conversation, Respondent agreed to a new appearance date and time of October 12, 2007, at 9:00 AM. By letter dated September 27, 2007, the

Commission confirmed that, at Respondent's request, her appearance to give testimony had been adjourned to October 12, 2007, at 9:00 AM. A copy of the letter is annexed as Exhibit J.

26. On or about October 12, 2007, the Commission was prepared to proceed with Respondent's testimony as scheduled at 9:00 AM, in the presence of a Referee who had been designated to preside. However, at approximately 10:00 AM, when Respondent had not arrived and had not called or otherwise communicated that she would be late, a record was made of her failure to appear, and various documents were marked as exhibits. A copy of the transcript is annexed as Exhibit K. At approximately 11:00 AM, Respondent appeared at the Commission, but the Referee had already departed, and further proceedings were not held.

27. By letter dated November 26, 2007, the Commission (A) notified Respondent that it had not received copies of her court's check register, as requested; (B) asked her to provide a complete copy of her check register by December 3, 2007; and (C) informed her that her failure to do so may be viewed by the Commission as a failure to cooperate. A copy of the letter is annexed as Exhibit L. Respondent failed to respond to the letter or provide the Commission with a copy of her check register.

28. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section

100.1 of the Rules; and failed to avoid impropriety and the appearance of impropriety, in that she failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules.

CHARGE V

29. From in or about January 2008 through in or about November 2008, months after Respondent had left judicial office, Respondent failed to cooperate with the State Comptroller, the Chenango County District Attorney's Office, other judges and court officials concerning her apparent financial, reporting and recordkeeping practices and deficiencies.

Specifications to Charge V

30. On or about January 1, 2008, Paul O'Connor succeeded Respondent as the Plymouth Town Justice after the expiration of Respondent's term on or about December 31, 2007. Upon assuming the bench, Judge O'Connor was unable to locate various court records from Respondent's tenure as the town justice.

31. By letter dated January 25, 2008, Chenango County First Assistant District Attorney Stephen M. Dunshee (A) notified Respondent that he and Judge O'Connor had been unable to locate the Plymouth Town Court's closed and pending criminal records and (B) asked Respondent to contact him or Judge O'Connor to assist them in locating and retrieving such records. A copy of Mr. Dunshee's letter is annexed as Exhibit M. Respondent failed to respond to the letter.

32. By letter dated January 30, 2008, Judge O'Connor requested that, without further delay, Respondent return court records in her possession either to the court or to the town custodian of records. A copy of the letter is annexed as Exhibit N. Respondent failed to respond to the letter.

33. By letter dated March 13, 2008, Judge O'Connor wrote that he had recently been notified by the Department of Motor Vehicles (DMV) that, in or about February 2008, Respondent had reported dispositions of traffic tickets to DMV. Judge O'Connor requested that, inasmuch as Respondent was no longer a town justice, she cease all activities on behalf of the court. He also requested that she return all court records in her possession to the Plymouth Town Clerk without further delay. A copy of the letter is annexed as Exhibit O. Respondent failed to respond to the letter.

34. By certified letter dated May 8, 2008, Dennis W. Donnelly, the Director of Internal Affairs at the Office of Court Administration, notified Respondent that his office had scheduled an audit of the records and practices of the Plymouth Town Court. Mr. Donnelly wrote that his office had been informed that Respondent had certain official court records in her possession and that, despite several efforts by the Chenango County District Attorney, the Plymouth Town Court Justice and the Office of Justice Court Support, Respondent had not returned such records. Mr. Donnelly requested that Respondent deliver all records of the Plymouth Town Court in her possession to Mr. Donnelly, or his personal designee, on May 22, 2008, at 11:00 AM, at the Chenango County Court, 5 Court Street, Norwich, New York. A copy of Mr. Donnelly's letter is annexed as Exhibit P. Respondent failed to respond to the letter and failed to appear at

the Chenango County Court on May 22, 2008, as requested. As a result, the court system's Office of Internal Affairs was unable to complete its audit of the Plymouth Town Court.


35. By letter dated June 5, 2008, addressed to Respondent at her personal mailing address, the State Comptroller (A) notified Respondent that she had made an error in writing a check remitting \$14,560 in court funds to the State Comptroller and (B) requested that she send a correctly written check to the State Comptroller. In or about July 2008 and August 2008, employees of the State Comptroller attempted to reach Respondent multiple times by telephone concerning the State Comptroller's continuing request that Respondent send a correctly written check. Respondent failed to send the State Comptroller a correctly written check until in or about November 2008.

36. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that she failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that she failed to maintain professional competence in judicial

administration and failed to cooperate with other judges and court officials in the administration of court business, in violation of Section 100.3(C)(1) of the Rules.

WHEREFORE, by reason of the foregoing, the Commission should take whatever further action it deems appropriate in accordance with its powers under the Constitution and the Judiciary Law of the State of New York.



If so, was the bail subsequently transferred to you by the sheriff's department?
3. Did you deposit the [REDACTED] bail into your official bank account? If so, please state when you deposited it into your account and provide copies of the appropriate receipt, cashbook entry, deposit ticket, and bank statement documenting the deposit of the [REDACTED] bail.
