FORMAL WRITTEN COMPLAINT

E. TIMOTHY MERCER,

a Justice of the Athens Town Court,

- 1. Article VI, Section 22, of the Constitution of the State of New York establishes a Commission on Judicial Conduct ("Commission"), and Section 44, subdivision 4, of the Judiciary Law empowers the Commission to direct that a Formal Written Complaint be drawn and served upon a judge.
- 2. The Commission has directed that a Formal Written Complaint be drawn and served upon E. Timothy Mercer ("Respondent"), a Justice of the Athens Town Court, Greene County.
- 3. The factual allegations set forth in Charge I states acts of judicial misconduct by Respondent in violation of the Rules of the Chief Administrator of the Courts Governing Judicial Conduct ("Rules").
- 4. Respondent has been a Justice of the Athens Town Court, Greene County, since January 1, 2020. His term expires on December 31, 2023. Respondent is not an attorney.

- 5. Justices of the Athens Town Court serve part-time. In addition to his judicial position, Respondent is and, at all times pertinent to the allegations herein, was also the proprietor of Mercer Associates, a private contracting company, located at _______, Town of Athens, Greene County.
- 6. The Justice Court Assistance Program of the Unified Court System ("JCAP") provides annual grants to towns and villages for court improvements, including security enhancements, renovations, and furnishings.

CHARGE I

- 7. From in or about September 2020 to in or about February 2022, in connection with the Town of Athens 2020-21 JCAP application and the receipt of JCAP funds, Respondent:
 - A. surreptitiously, and without notification to the pertinent Town officials or his co-judge, directed that a security camera system be added to the application;
 - B. awarded the camera-installation contract to his own company, Mercer Associates, contrary to law, notwithstanding his conflict of interest and without notifying the pertinent Town officials of his conflict;
 - C. charged the Town, in his capacity as owner of Mercer Associates,\$3,329.99 for the purchase and installation of the security camera

- system, which included a \$1,000 installation fee and an otherwise undisclosed markup fee of \$760;
- D. signed a Town of Athens voucher in his capacity as town justice,
 authorizing payment of an invoice to his own company, Mercer
 Associates, to be paid from a combination of JCAP funds and court
 budget funds;
- E. invoked his judicial office in an attempt to persuade the Town to pay the Mercer Associates invoice after being notified that payment was being withheld;
- F. continued to insist that the Town pay the invoice, and charged an added interest fee for nonpayment, even after he acknowledged to his supervising judge that his conduct created at least an appearance of impropriety; and
- G. failed to cooperate with Town officials by refusing to sign for and accept copies of the Town's handbook, procurement policy and ethics code.

Specifications to Charge I

8. In or about September 2020, Respondent, Athens Town Justice

Constance Pazin, and Senior Court Clerk Marcia Puorro discussed submitting a

2020-21 JCAP application for grant assistance to the court. They agreed to include

in the application a request for funds to purchase two air conditioners, window blinds, a paper shredder, and a desk chair, and a request for certain reimbursements related to COVID-19 expenses.

- 9. By letter dated September 21, 2020, Ms. Puorro asked the Athens Town Board to adopt a resolution authorizing the Athens Town Court to apply for a JCAP grant to purchase "2 Air Conditioners, new Window Blinds, a new Shredder, a Desk Chair and Reimbursements from COVID Expenses." Ms. Puorro copied Respondent and Judge Pazin on the letter. A copy of the letter is annexed as Exhibit A.
- 10. On or about October 5, 2020, the Athens Town Board adopted a resolution authorizing the Athens Town Court to apply for a JCAP grant to purchase "2 new Air Conditioners; new Window Blinds; a new Shredder, a Desk Chair and Reimbursement from COVID expenses." A copy of a letter dated October 6, 2020, from Linda M. Stacey, the Athens Town Clerk/Tax Collector, memorializing the adoption of the resolution is annexed as Exhibit B.
- 11. Between on or about September 21, 2020, and October 7, 2020, Respondent directed Ms. Puorro to add a security camera system onto the court's 2020-21 JCAP application, notwithstanding that the court had not sought authorization from the Athens Town Board to include that item in its 2020-21 JCAP application and the Town Board had not authorized the court to do so.

- 12. On or about October 7, 2020, Ms. Puorro submitted the court's 2020-21 JCAP application to the Office of Justice Court Support. The application included, at Respondent's direction, a request for JCAP funds in an amount of \$3,329.99 for "Video Surveillance, alarm systems, etc.", with the comment: "Security Camera System for the hallway as well as Court room and Office. Due to COVID especially, clients have to wait in the hallway as well as the courtroom and there is no Security." A copy of the court's 2020-21 JCAP application is appended as Exhibit C.
- 13. Respondent did not notify Judge Pazin or Athens Town Supervisor Robert Butler about the addition of the security camera system to the 2020-21 JCAP application.
- 14. On or about October 7, 2020, Ms. Puorro separately sent a fax to the Office of Justice Court Support containing the JCAP Signature Page, a copy of the Town Board resolution, and supporting documents regarding the items requested. One of the supporting documents is a printout of a listing from the website cctvsecuritypros.com, for a "Model: CSP-4POEMX8-S" security camera system. Respondent handwrote on the document: "2,329.99." Underneath that handwritten figure appears another handwritten notation: "+1,000 Installation." A copy of the printout from cctvsecuritypros.com is annexed as Exhibit D.

- 15. On or about November 25, 2020, Kathleen Roberts, an Assistant Court Analyst at the Office of Justice Court Support, sent an email to Ms. Puorro asking for "a new estimate that includes a breakdown of labor and itemized cost of materials as well as the exact location of where each camera will be placed."
- estimate dated September 2, 2020, from "Mercer Associates," that had been provided to her by Respondent's wife. The estimate listed the cost to purchase and install a "CSP-4POEMX8-S" security camera system at the court as \$3,329.99, with an itemization of \$2,329.99 for the cost of the system plus a \$1,000 installation fee. A copy of the estimate is annexed as Exhibit E.
- 17. On or about January 22, 2021, Ms. Puorro was notified by letter and an enclosed Reconciliation Report that the Athens Town Court had been awarded a 2020-21 JCAP grant in the amount of \$3,089.99 for the purchase of "Video Surveillance, alarm systems, etc." Copies of the award letter and the Reconciliation Report are annexed as Exhibit F and Exhibit G, respectively. The Athens Town Court's request for grant funds to purchase all other items was not granted.
- 18. The award letter stated that funds would be sent on or before April 1, 2021, to the Town of Athens and must be spent within 180 days of receipt. The award letter and Reconciliation Report both stated that, "If the amount you spend

purchasing the item(s) approved on the enclosed JCAP Reconciliation Report is less than the amount awarded, leftover funds are not to be used to offset the cost of another grant item awarded at a set monetary amount," and the recipient was instructed to contact the Office of Justice Court Support for further direction. The Reconciliation Report also stated that all goods and services purchased with JCAP funds "shall be obtained in accordance with acceptable procurement practices established by the governing municipality including, but not limited to, competitive bidding and procurement policies and procedures."

- 19. Respondent awarded the contract for such services to his own company, Mercer Associates, notwithstanding that it constituted a conflict of interest, and without publicly disclosing his interest in Mercer Associates, in writing to the Town of Athens, in violation of Sections 801 and 803 of the General Municipal Law and Sections 19-3 (C) and (G) of the Town of Athens Code of Ethics.
- 20. On or about June 3, 2021, Respondent purchased a "Model: CSP-4POEMIC8" security camera system from cctvsecuritypros.com for \$1,569.99, which was \$760 less than the cost of the "CSP-4POEMX8-S" model identified in the court's 2020-21 JCAP application, its supporting documentation, and the Mercer Associates estimate. Documentation of Respondent's purchase of the "Model: CSP-4POEMIC8" security camera system is annexed as Exhibit H.

- 21. In or about June or July 2021, Respondent installed the security camera system in and around the Athens Town Court.
- 22. On or about July 6, 2021, Respondent approved a Town of Athens voucher in the amount of \$3,329.99 to be paid to Mercer Associates for the purchase and installation of a "CSP-4POEMICX8-S" security camera system, by signing his name in the box on the form labeled "Department Approval." A copy of the voucher with attached invoice from Mercer Associates, both dated July 6, 2021, is annexed as Exhibit I. Notwithstanding that the camera system purchased by Respondent cost \$1,569.99, the voucher and attached invoice both falsely listed the cost of the camera system as \$2,329.99.
- 23. Because the court's JCAP grant award did not cover the entire amount Respondent had requested in the voucher, in the box on the form labeled "Fund Appropriation," \$3,089.99 was requested from the court's JCAP grant and \$240 was requested from the court's annual security budget.
- 24. Instead of contacting the Office of Justice Court Support for further direction or reducing the cost of the security camera system in the voucher and attached invoice by \$760, Respondent knowingly (A) charged the Town \$2,329.99 for the cost of the system and (B) intended to retain the additional undisclosed \$760 savings, notwithstanding that Section 138.2 of the Rules of the Chief

Administrative Judge and Section 849-h (2) of the Judiciary Law prohibits the use of JCAP funds to compensate justices.

- 25. Between on or about July 6, 2021, and on or about July 15, 2021, Don Pierro, the Athens Town Finance/Budget Officer, reviewed the voucher, noticed that it was seeking payment to Respondent's company, and reported the apparent conflict of interest to Robert Butler, the Athens Town Supervisor. As a result, Mr. Butler halted payment of the voucher and referred the matter to the Town attorney.
- 26. On or about July 15, 2021, after being notified that the Town was refusing payment of the voucher, Respondent sent an email from
- @nycourts.gov, his official court system email account, to Mr. Butler with copies to Mr. Pierro, Judge Pazin, Ms. Puorro, and his own email address at Mercer Associates (@mercerplg.com) in support of his request for payment to his company. The email's signature block identified Respondent as "Town Justice." A copy of the email is annexed as Exhibit J.
- 27. By email dated July 15, 2021, Mr. Butler advised Respondent that the Town was holding any payment made to Mercer Associates and reviewing whether it had been a violation for Respondent to use his own firm or any firm from which he would benefit financially. A copy of the email is annexed as Exhibit K.
- 28. On or about July 21, 2021, Respondent sent an email to Supervising Judge David Dellehunt, noting *inter alia* (A) that it had come to his attention that

the Town of Athens was "looking into an ethical issue with me" for having "performed billable labor that was in our approved JCAP application for Mercer Associates, my Company, and (B) that while he did not feel he had violated any town ethics policies, "the look of impropriety is enough . . ." A copy of the email is annexed as Exhibit L.

- 29. In or about early August 2021, Respondent went to Mr. Pierro's office, demanded payment of the voucher, and said he would charge interest if the Town continued to refuse payment.
- 30. On or about August 18, 2021, Respondent submitted another invoice to the Town of Athens, noting an "Overdue Balance" of \$3,329.99 and adding a "finance charge" of \$66.59, for a total of \$3,396.58. A copy of the invoice is annexed as Exhibit M.
- 31. Between in or about November 2021 and in or about February 2022, Respondent refused to cooperate with a request by Town officials that he accept and sign for copies of the Town of Athens' handbook, procurement policy and procedures, and ethics code. Respondent did not sign for and accept such materials until after he was questioned about his refusal to do so during his testimony before the Commission on February 7, 2022.
- 32. On or about December 30, 2021, Respondent submitted an invoice to the Town of Athens, showing a \$0 balance due and indicating that the camera

system had been removed. The invoice also stated "JCAP Terminated. Town to Return all Funds to NY State." A copy of the invoice is annexed as Exhibit N.

- 33. The Town of Athens returned the JCAP funds to the Office of Justice Court Support for failure to spend the award money within 180 days of receipt. As a result of the failure to spend the funds awarded for 2020-21, the court was disqualified from requesting a JCAP grant for 2021-22.
- By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article VI, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules, and lent the prestige of judicial office to advance his own private interest, in violation of Section 100.2(C) of the Rules; failed to perform the duties of judicial office impartially and diligently, in that he failed to have his judicial duties take precedence over all his other activities, in violation of Section 100.3(A) of the Rules, failed to be faithful to the law and maintain professional competence in it, in

violation of Section 100.3(B)(1) of the Rules, and failed to maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules; and failed to conduct his extra-judicial activities so as to minimize the risk of conflict with judicial obligations, in that he failed to conduct all of his extra-judicial activities so that they do not cast reasonable doubt on the judge's capacity to act impartially as a judge, detract from the dignity of judicial office or interfere with the proper performance of judicial duties and are not incompatible with judicial office, in violation of Sections 100.4(A)(1), (2), and (3) of the Rules, and failed to refrain from engaging in financial and business dealings that may reasonably be perceived to exploit the judge's judicial position, in violation of 100.4(D)(1)(a) of the Rules.

WHEREFORE, by reason of the foregoing, the Commission should take whatever further action it deems appropriate in accordance with its powers under the Constitution and the Judiciary Law of the State of New York.
