Judicial Conduct Commission Re-Elects Joseph W. Belluck as Chair and Taa Grays as Vice Chair

At its meeting of June 18, 2026, the New York State Commission on Judicial Conduct unanimously re-elected Joseph W. Belluck as Chair and Taa Grays as Vice Chair for two-year terms.¹

Mr. Belluck is the founder of the Manhattan law firm Belluck Law. He has served on the Commission as a gubernatorial appointee since 2008, and has been Chair since 2016.

Ms. Grays, formerly Vice President & Associate General Counsel for Information Governance at MetLife, is currently serving as president of the New York State

¹ Commission members serve for renewable four-year terms, by appointment of the Governor, the Chief Judge or the leaders of the Legislature. The Chair and Vice Chair are elected by the members and serve renewable two-year terms.

Bar Association. She is an appointee of the Senate President Pro Tem, has served on the Commission since 2017, and has been Vice Chair since 2020.
